Just the Facts.....

- QCP continues to be a major employer in Queens. We are hiring in many of the programs and the Personnel Department has incentives for new employees to join our team.
- The Children's Center was pleased to be back to fully in-person learning and therapy this past September. Many COVID-19 precautions remained in place, but the children came into school daily. The health and safety of our children and staff continued to be our top priority.
- This school year we had about 90 students, including 10 children who were in an
 inclusionary class and 33 children who were typically developing. Our new 3K class
 for neighborhood children opened in September 2021 and has been a great
 success. Our staff's dedication and wonderful abilities are what made 2021/2022 a
 terrific school year.
- Many of QCP's Supported Employment individuals continue to be front-line workers in stores and supermarkets throughout the pandemic. Over 150 persons continue to be employed through Supported Employment.
- Day Programs came back to both in-person and remote programming. Many of the participants missed the in-person programming and were happy to return, even if on a socially distanced basis.
- The Pre-Voc Program continues to volunteer at various sites to help the community. This program helps individuals take the next step in obtaining employment by volunteering at community sites—our front-line volunteers!
- Families continued to benefit from our "Family First" program which permitted funding for respite, medical and equipment needs in times of crisis.
- The Article 16 Clinic came back in– person and continues to use Zoom and Remote Visits to those who are not comfortable with the in-person setting.
- QCP's Family Support Services-Non-Medicaid Case Management continue to serve individuals and families secure Medicaid eligibility and get referrals to OPWDD.
- QCP's Article 16 Clinic at Bellerose continues to provide access to clinical services including Physical Therapy, Occupational Therapy, Speech, Psychology and Nursing.
